We are writing to update you on some issues that are developing in the Village of Brookville. Of course, the Tam O'Shanter issue will affect the neighboring villages, as well. The good news is that changes are taking place. The Village of Brookville's new web site is up and running, but is still a work in progress. It is a vast improvement in providing news to the residents. The second change is that there are plans for construction of a centralized administrative facility and with it, potentially, a community center.

We would like to get a sense of the residents' priorities with regard to the projects they would like to see the Village Board undertake and on a few issues that will affect our lifestyles in the villages. ## Cedar Swamp Road

Do you have any concerns about the safety of Route 107? Although it is a state road and a New York State responsibility, it is the major thoroughfare through the villages and is no longer a leisurely drive through the countryside. The volume of traffic on the road has multiplied with the development of destination sites and new housing in Glen Cove. We believe that the Village of Brookville has the responsibility to be the leader in the redevelopment of the road. The Village lacks a plan to develop pedestrian access within the Village. Route 107 is not developed for today's community needs. Bike riding is a high-risk activity. Walking is not recommended at all.
